**I consent to Cane River Creole Heritage Pageant** photographing or videoing as he/she will be taking part in the **Cane River Creole Heritage Pageant** Event.

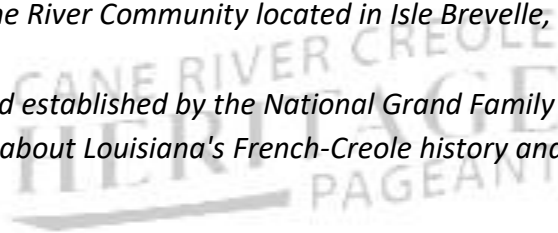
